 - a. A fully completed application form
 - b. Registration fee of £8 (made payable by cheque to **Trinity Arts and Craft Guild**)
 - c. A recorded CD by the two applicants which should include two songs (one of them by Schubert)
2. The entries should be sent to the above address **Chelsea Schubert Festival, Holy Trinity Sloane Square, Sloane Street, London, SW1Z 9BZ. (deadline for entries is 1st August 2009)**
3. The successful duo will be notified by mid August and invited to perform in the first round on the September 16th 2009 at Holy Trinity Sloane Square in front of a judging panel. The duo will be asked to perform two songs (different to those on the CD) and one of these should be by Schubert.
4. The successful duo will be notified at the end of the performances on 16th September 2009 and invited to perform in the final round on the September 17th 2009. The duo will be asked to perform three songs (one may be repeated from the previous rounds) and one of these should be by Schubert.
5. The prizes for first and second prize will be awarded after final deliberation on 17th September 2009.
